The Stewards also reviewed #6 Wagon Lion drifted in approaching the finish, causing #4 Rji Cashing In to be squeezed out at the wire. The Stewards' reviewed the race video replay, spoke with the jockeys and disqualified #5 Jesstuffeyed Billy from 1<sup>st</sup> to 5<sup>th</sup>. Then the Stewards disqualified #6 Wagon Lion from its new placing of 1<sup>st</sup> back to 2<sup>nd</sup>.
